The Painter for City Council bank account was opened with a prohibited cash contribution of \$100 on July 13, 2009. Election law prohibits that a cash contribution be received in excess of \$50. Per the State Board of Elections, it is allowed that this situation be resolved by a paper trail from New Bridge Bank. A bank refund of the \$100 to the candidate (contributor) must be made and then another contribution may be entered to restore that balance. Evidence of this transaction may be electronic and must be sent with this signed letter as soon as completed. This activity must also appear on the Pre-Primary report that is due on September 8 with period report dates of 8/5/09 to 9/1/09.

PLEASE SIGN BELOW:

I, James E. Painter, do acknowledge that the \$100 cash contribution to open the Painter for City Council bank account was taken from my personal funds but is prohibited by NC Election law because it is in excess of \$50. New Bridge Bank has reimbursed the contribution.
