- 3. Affiliated with political party for 75 days by date of filing Notice of Candidacy (i.e. if filing on last day of filing period, party affiliation must have been changed by October 7, 2015.)
- 4. Residency Requirement (State Senate 2 years in State, 1 year in district, NC Const., Art. II, Sec. 6); (State House, 1 year in district, NC Const., Art. II, Sec. 7); County Commissioner and Superior Court Judges must reside in the district; Congress NC resident, residence not required in the district.
