**Meeting Minutes**

**November 7, 2025 – 12:00 p.m.**

**Meeting Called to Order**

A meeting of the Forsyth County Board of Elections was called to order in the 2<sup>nd</sup> Floor Board Room on Friday, November 7, 2025 at 12:01 p.m., Chairperson A.L. Collins presiding.

**Pledge of Allegiance**

Chairperson A.L. Collins led the Pledge of Allegiance.

**Moment of Silence**

Chairperson A.L. Collins led a moment of silence.

**Public Comments**

Chairperson A.L. Collins called for public comments, providing two minutes per speaker:

Member Draper moved to close public comments; Member Harvey seconded. **Motion carried unanimously.**

**Motion to Approve Meeting Agenda**

Chairperson Collins called for a motion to approve the agenda as presented. Vice Chair Jourdan moved to approve the agenda as presented; Member Draper seconded. **Motion carried unanimously.**

### **Approval of Meeting Minutes**

Vice Chair Jourdan presented the meeting minutes for the October 28, 2025 and the November 3, 2025 meetings. Member Draper moved to approve the minutes as presented; Member Harvey seconded. **Motion carried unanimously.**

Director Tsujii informed the Board that there was a county wide internet outage the day before and that a ISB internet service was deployed to allow for work to continue.

### **Approval of Voter ID Exception Forms**

Director Tim Tsujii presented to the Board the provisional voter photo ID exception forms for review. Secretary Doomy moved to disapprove one photo ID exception form and to approve all the other voter ID exception forms as presented; Member Harvey seconded. **Motion carried unanimously.**

### **Review of Absentee Cure Ballots**

Macy Payne, Absentee Ballots Manager, presented one accepted cure absentee ballot for review. Member Draper moved to approve the ballot envelope as presented; Member Harvey seconded. **Motion carried unanimously.**

### **Review of Provisional Disposition**

Kay Moore, Voter Registration Manager, presented to the Board the provisional ballots for review. A total of 74 ballots were presented for approval and 91 ballots presented for disapproval. Member Draper moved to approve 74 provisional ballots and to disapprove 91 provisional ballots; Vice Chair Jourdan seconded. **Motion carried unanimously.**

### **Tabulation of Provisional Ballots and Outstanding Absentee Ballots**

Board Members signed absentee abstract report.

Board Members signed Zero Reports for the DS200 tabulator.

Member Draper moved to approve the absentee abstract report and zero reports as presented; Member Harvey seconded. **Motion carried unanimously.**

Director Tsujii informed the Board that a bipartisan hand count of precinct 067 had been conducted and that the results showed 100% accuracy. This precinct is currently piloting new software in this election. The new software will be presented the following week to the Board.
